Message from the Club Board

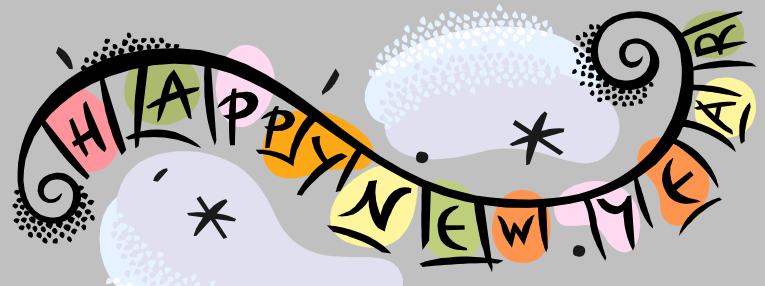
Happy New Year! We hope that you all had a wonderful start to 2010 and look forward to seeing you all at the range over the year.

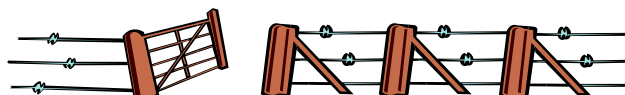
